- ❖ **Guiding Principles for Equitable CORs:** At the March 21st meeting, CCC approved this document, which will serve as a resource for faculty when creating or updating CORs from an equity perspective. The document will be forwarded to Academic Senate for review and final approval. Additionally, CCC continued discussing the creation of a process for adopting these guidelines across all academic divisions. The group brainstormed potential ways faculty could indicate/explain how they have incorporated equity into a COR (e.g., checkbox and/or text field on the COR form in CourseLeaf) and discussed which people/groups might be involved in reviewing equity-related updates to CORs. Also discussed was the importance of professional development and other types of support, to ensure all faculty are equipped with the knowledge they need to incorporate equity into their CORs. CCC will continue discussing this important topic in spring quarter—if you would like to be involved, please reach out to your CCC Reps.
