### **(5) PRC GENERAL OBSERVATIONS**

Carolyn Holcroft - program review was discussed at faculty assoc meeting this past Monday, positive comments regarding participation, more instances of many authors writing sections vs only one or two writing sections, concerns regarding PRC only reviewing comprehensive reviews  
Andrew LaManque – there has been discussion regarding PRC reviewing comprehensive only, feedback is mainly from the dean on annuals, programs are concerned that they only get PRC feedback every three years, issue has come up before but PRC does not have resources to review every annual review  
Nanette Solvason – suggest to allow programs with third party accreditation to be exempt from comprehensive PR during those years  
Carolyn Holcroft – possible suggestion is to have program directors identify where there are overlaps between accreditation studies and PR, possibly allowing PR to use part of their accreditation reports to avoid redundant work for programs  
Andrew LaManque – presents PRC gen observations  
Carolyn Holcroft – looking for equity feedback in PR comments, some had others didn’t, wants to encourage feedback that gives actionable items rather than just saying to continue discussing equity  
Thuy Nguyen - can we revise PR recommendations to include discussion vs implementation  
Andrew LaManque – can consider adding that to the next PR cycle  
Ramiel Petros – is there issue with grading different programs on the same rubric (ex: English department vs transfer center) does having these general rubrics cause some yellow or red flags to get lost in the overall grading  
Debbie Lee – departments do address their shortcomings in yellow/red categories but those don’t always get addressed in their overall green/yellow/red grades  
Carolyn Holcroft – getting a red grade for PR means this program needs attention and resources so it’s important to recognize the needs of the program

Debbie Lee – presents, NCBS non credit certificate program proposal. Program goals and objectives revised based on feedback. want to give students alternatives to fulfilling math requirements.

Dave Sauter – presents program creation proposal for landscape tech cert, use existing curriculum to craft a certificate pathway for students to get certification, minorities historically interested in this pathway now have higher certification program to prep them for careers in landscape maintenance, create new opportunities for short certification program
