The Board approved OmniUpdate as the preferred web content management system for the District. De Anza has been using OmniUpdate for 6-7 years and Central Services will soon be migrating to Omni. It is now available for use by Foothill if the college chooses to change systems. Judy Baker will request OmniUpdate training support in her program review.

4. Review recommended updates to Foothill College Technology Master Plan 2010-2015 (http://foothill.edu/staff/irs/ESMP/docs/EMP2010/Foothill\_Tech\_Plan\_11.9.10.pdf)

At the previous meeting, it was agreed that the Foothill College Technology Master Plan would remain a 5-year plan with 1-year reviews built in. There was some misinterpretation between annual reviews with update suggestions versus an actual rewrite. Because the document sounded very dated in some sections, the committee agreed a rewrite was in order. The document would become the "Foothill College Technology Master Plan 2010-2015, 2014 Update". Kurt Hueg will distribute an electronic version (Word doc.) for members to edit. Judy Baker and Akemi Ishikawa will compile and incorporate changes into a draft version for members to review.
