- ❖ **New Subject Code:** The Apprenticeship division has approved a new subject code of Installer Technician Sound & Communication (ITSC), which will go into effect for the 2019-20 catalog. Initially, one new course, ITSC 400, will be offered under the new code.

- ❖ **ASCCC Spring Plenary Resolutions:** CCC has shared resolutions that will be discussed at the spring ASCCC plenary session. For a copy of the resolutions, and to engage in discussions with your colleges, please contact your CCC Reps.

- ❖ **Temporary Program Creation Process:** At the March 19th meeting, CCC approved a Temporary Program Creation Process, for use until a replacement to our formal process has been finalized. The temporary process includes a Feedback Form for New Programs, to be used by faculty creating a new program to gather feedback from governance groups. - ❖ **Courses not Taught in Four Years:** In keeping with our annual process related to course currency, at the March 19th meeting CCC reviewed the deactivation exemption request forms submitted by divisions for courses on this year's list. - ❖ **Credit by Exam:** At the March 19th meeting, CCC continued discussion of this topic, via a second read of a draft process by which a faculty member submits a course to be included in the list of Credit by Exam

courses published in the college catalog. As before, much of the discussion concerned how to handle a situation in which the instructor of record for a course on the Credit by Exam list does not wish to administer the exam. CCC decided to not bring the process to a vote at this meeting, so it will return for a third read. If you are interested in adding to the conversation, please contact your CCC Reps.

- ❖ **Auto-awarding Degrees and/or Certificates:** At the March 19th meeting, CCC also held a second read of a CCC Resolution in support of auto-awarding degrees and/or certificates to students who have completed the requirements. The thoughtful discussion included concerns around how such a process could impact certain student groups (e.g., international students) and the high volume of work necessary to implement an auto-awarding process, as well as voices in support of the wider topic of helping students achieve their goals via mentorship, engagement, and encouragement. CCC agreed to bring the resolution back for a third read before bringing it to a vote, so there is still time to provide your feedback—as always, touch base with your CCC Reps to contribute.
- ❖ **OER Workshops:** The Academic Senate for California Community Colleges (ASCCC) is hosting weekly Open Educational Resource (OER) webinars on Fridays at 9:30am. Each webinar will focus on the available OER resources for a specific discipline, with faculty sharing their experiences adopting OER.
