- ❖ Web Browser Compatibility with C3MS: We have recently discovered some compatibility issues with certain web browsers when viewing CORs in C3MS. For best results, our system administrator, Bradley Creamer, suggests that all C3MS users use Chrome.
- ❖ Foothill GE Subcommittees: At the January 21st meeting, CCC began a discussion regarding our current model of using subcommittees to review GE requests. These subcommittees are staffed by faculty volunteers, who review both requests from faculty to add courses to the Foothill GE areas and requests from students to receive GE credit for courses taken at a different college. In recent years, faculty participation in the subcommittees has waned, which prompted the need for CCC to discuss the sustainability of the subcommittee model. Discussions on this topic will continue at future meetings; if you are interested in providing feedback, please get in touch with your CCC Reps.
- ❖ Honors Course Prerequisite: Also at the January 21st meeting, CCC continued discussion on the topic of the possible removal of the prerequisite of "Honors Institute participant," which is currently enforced on all honors courses. Included in the discussion was an important update from Articulation Officer Evan Gilstrap, who has confirmed with UC that we will need to reapply for UC transfer approval for any course which is

removing the honors prerequisite (and, following that, we would need to reapply for CSU GE, IGETC, and C-ID approvals, if applicable to the course). Discussions on this complex topic will continue at future meetings; please contact your CCC Reps with any questions or to provide feedback.
