- Resolution to Support Blanket Distance Education Addendum: In response to campus closures due to the COVID-19 pandemic, the state Chancellor's Office's is permitting community colleges to request an Emergency Blanket Distance Education Addendum, which will allow us to move to online delivery for our courses that are not already approved to be taught via Distance Ed. CCC held an emergency vote via email between March 11-13, to consider a CCC Resolution in support of Foothill's submission of this addendum. The resolution was approved and has been posted on the CCC Policies & Resolutions webpage.
