Support Faculty to Explore and Adopt OER:** At the October 19th meeting, CCC approved the Resolution to Explore Options to Leverage College Curriculum Processes to Support Faculty to Explore and Adopt OER. Created in conjunction with Academic Senate, the intent of the resolution is to raise awareness and hopefully increase the use of OER across campus, in part by making it easier for faculty to find OER resources. - CORs must be in "Curriculum Coordinator Review1" status, on or before this date, to be reviewed by Mary for the 2022-23 catalog

- *Friday, November 5th*: Deadline to submit Foothill GE applications (for existing courses) for 2022-23
 - Foothill GE application forms are now part of the COR form in CIM, so our regular COR updating process/workflow applies
 - CORs must be in "Curriculum Coordinator Review1" status, on or before this date, to be considered for Foothill GE for the 2022-23 catalog
