- ❖ Equity in the COR: At the March 15th meeting, CCC engaged in discussion around the topic of incorporating equity into Foothill course outlines of record (CORs). To guide in brainstorming ways to ensure equity is being considered in COR development, the group reviewed examples of what some other California community colleges are doing (e.g., using certain language/tone in course description, SLOs, and other sections). The group also talked about potential challenges, including articulation-related concerns and ensuring faculty's academic freedom. This is a major topic of discussion which will continue at spring quarter CCC meetings, to give the group enough time to make a well-considered decision on how to move forward. - Guided Pathways Mapping Approval Process: On March 15th, CCC held a first read of a process to be used for both the creation of new Program Maps and the revision of existing Maps. Guests from the Guided Pathways Team—Amy Leonard, Isaac Escoto, and Natalie Latteri—presented the process, which includes a detailed step-by-step process for Map creation/revision, a submission form (for approval of the finalized new/revised Map), and workflow/steps for approval of the finalized Map.
