Note re: NCBH 400 and NCBS 405. Given that the BHS division will no longer exist, BHS considered three options for our current Supplemental Instruction classes. The options were as follows, with the recorded votes indicated.

Option 1 (received 2 votes) = leave NCBH 400 as is, with BIOL, HORT and program courses. Option 2 (received 8 votes) = move BIOL courses to NCBS 405, retain HORT and program courses in NCBH 400.

Option 3 (received 3 votes +1 via e-mail) = move BIOL courses to NCBS 405, move HORT and program courses to a new course with new name to reflect the new division/workgroup.
