## **Other Topics Discussed:**

We focused on standardizing the language around testing and prerequisites for English composition and literature classes.

We noted the universal removal of prerequisites for all honors courses, and the need for standardized language and requirements for our honors literature courses.

Another important discussion focused on the ownership of courses, how to better distribute ownership, including deliberate grouping of courses for easier updates, or based on recent teaching. Related to this issue was the question of whether we need collective department input for Title V edits, including textbook selection and updates.

We know that ownership will be affected by the unique editor status in CourseLeaf, and this will be on our agenda for Fall 2020.

It will be valuable to consult with the Curriculum Best Practices Ad Hoc Committee moving forward to better streamline our own LACC records and process.
