#### **IEC Membership**

  - Classified Staff: Classified Senate
  - Faculty: Academic Senate
  - Student: ASFC
- Membership term length: 2 years



#### **IEC's Purpose**

- Focus on continuous improvement efforts that drive the college mission
  - Facilitate college-level discussions about institutional improvement efforts
  - Support assessment and evaluation of institutional plans and initiatives for effectiveness
  - Promote cross-college dialogue



#### **IEC's Charge**

- The Institutional Effectiveness Committee serves to promote ongoing and continuous improvement through the evaluation and assessment of college processes that supports the mission and advance institutional quality.
- This committee meets every 3-4 weeks and reports to MIPC.



#### IEC's Purpose + Accreditation

 ACCJC Standard 1.4: The institution's mission directs resource allocation, innovation, and continuous quality improvement through ongoing systematic planning and evaluation of programs and services.




Vision 2030

#### Plan/Initiative Overview for the IEC

**Activity** 

- Last version of plan OR when initiative began
- Timeline cycle: Where are we in the cycle? Is there a deadline?
- What are some key goals, metrics, or activities?
- Share progress on these goals, metrics, activities
  - What has gone well? Where is more support needed?
- Where/How is this information reported/shared?
- What resources do you use/may need?
- What are the next steps for this academic year?
- Is this work ongoing? Does it sunset, and if so when?

- How will we know the IEC is functioning and effective?
- How does IEC communicate its work with the rest of the college (or is it through the various college plans/initiatives)?
