One of the action items previously identified was the need of new marketing materials. We have brand new program cards on order now, and hope to start passing them out to prospective students right away. We also implemented RSI strategies as a department, identifying how we can better reach all students. Additionally, we plan to offer at least one unique class this Spring and two others in the next school year and are currently holding interviews for Spanish speaking faculty. We're also highlighting our campus' new lounge spaces, connecting students to spaces in which they'll feel welcome.

We plan to offer at least one unique class this Spring and two others in the next school year, and are pursuing offering Spanish instruction courses for the general population in an East Palo Alto location.

While we have similar success rates to the college overall, we do note that success rates amongst Black, Latinx, Pacific Islander, men, foster youth and low-income students are lower.

Male students -10%, 20 additional successes needed

Black students -28%, 34 additional successes needed

Latinx students -4%, 37 additional successes needed

Pacific Islander students -21%, 35 additional successes needed

Foster Youth students -32%, 6 additional successes needed

Low- Income students -10%, 116 additional successes needed

To improve these numbers, we've implemented increased check-ins with students, are sharing Foothill resources, and are in the process of hiring more diverse staff all of which we identified in our Comprehensive Program Review last year, we're hopeful our efforts pay off, increasing course success.
