The actions for improvement identified in the most recent Annual Program Review include: (1) Work with ETS and the Garden to provide on-campus computer access; (2) Increase certificates and degrees awarded by collaborating with counseling to remove barriers to students applying for earned awards; and (3) Build in projects and curriculum to emphasize GIS as a tool of social justice and highlight diverse GIST professionals. In addition, in the Annual Program Review the Dean's summary noted that the program is working to close the success gaps between introductory level and higher level classes.

6. What actions identified in the Comprehensive Program Review (or most recent Annual Program Review if no Comprehensive Program Review) have you completed this year?

Goal 1: Collaboration and Technology Updates The program continued collaborating with the Foundations Garden STEM tutorial center in 2023-24, while the Library enhanced resources by installing large-screen computers for Geographic Information Systems Technology (GIST) access.

Goal 2: Addressing Barriers to Degree and Certificate Completion Despite some challenges, the program worked with the Counseling Division to address barriers to degree and certificate completion, focusing on improving communication and guiding students through application processes. These efforts contributed to the awarding of 33 degrees and certificates in 2023-24, a 10% increase from the prior year.

Goal 3: Curriculum Updates The GIST faculty are actively updating the curriculum to emphasize social justice and equity applications, aligning with institutional goals to promote equity-minded practices and address real-world challenges.

Our implementation timeline remains unchanged, and faculty are working diligently to address all program goals.

The GIST program used Program Review data and Disproportionate Impact data provided by college Institutional Research to evaluate progress toward our goals. Department faculty continue to work closely with the campus tutorial centers and outreach groups to provide timely, targeted support to students. We have worked to train tutors to help our students. They provide a full tutoring schedule that includes in-person and online tutoring plus tutoring after hours.
